## Background

In summer of 2015, a committee sponsored by John Krogman, DoIT COO, was charged with assessing the campus content management system (CMS) landscape and making recommendations for campus CMS. The committee submitted to the CIO, DoIT COO, and MTAG two documents, one in 12/2015 with factual findings and a final report in 5/2016 with recommendations. In summer of 2016, MTAG endorsed the final report, part of which recommended implementing a campus-scoped Drupal solution. Additionally, the recommendations included that the campus-scoped Drupal service should be established using the campus assessment line item for WiscWeb (campus CMS service).

## Facts

- There is a viable contract offer from Acquia available now that will expire in the short term. The price has already risen over the past year due to inaction.
- This will allow a shared Drupal service on campus in alignment with our cloud-first strategy, and likely solution improve security through consolidation.
- This would allow those currently running Drupal servers to spend more time with users, rather than running their own infrastructure and software.
- The length of time taken in the decision making process is causing harm to the Drupal customers as they are in a holding pattern waiting for a decision to be made.
- The Acquia solution will add a more reliable, more secure, more robust development than anything we have running on campus.

## Why DTAG?

- This affects Divisional IT most of all
  - Divisional IT is running the servers
  - Divisional IT is working with the customers
- DTAG should have a voice in how their campus assessment funds are spent.
- As good stewards of campus funds, DTAG should ensure that shared solutions meet the needs of as many campus units as possible.

Proposed Recommendation:

As this affects divisional IT currently supporting Drupal servers, and their customers, DTAG recommends that a shared Drupal solution for campus be finalized by signing a campus scale solution contract with Acquia as soon as possible.
