- Canvas- Currently looking for funding procurement to move forward. Assuming we will get
 the money we need, we are moving ahead with our support model. while faculty are free to
 move to Canvas at any time, based on direction from their school or college, there are
 several schools and colleges beginning a concerted transition effort with central IT support
 assistance this spring. Those schools and colleges are Medicine and Public Health, Law,
 Agricultural & Life Sciences, Human Ecology, and several departments within Letters &
 Science.
